ABOUT THE ROLE

The Regional District of Nanaimo is seeking two (2) temporary full-time Operator Trainees to work at the French Creek Pollution Control Centre (FCPCC) and Greater Nanaimo Pollution Control Centre (GNPCC) with Wastewater Services in the Regional and Community Utilities Department.

Reporting to the Chief Operator, Wastewater Services, the Operator Trainee will perform a variety of unskilled and semi-skilled tasks. This position will require moderate physical effort and agility as well as an above average mechanical aptitude in the Wastewater field. In addition to assisting their Chief Operator, the Operator Trainee's duties will consist of operations, maintenance and routine housekeeping of the facilities. The Operator Trainee will be located at either FCPCC or GNPCC, and they must be available to work at either site as operationally required.

QUALIFICATIONS

Applicants must be eligible to write the Operator-In-Training (OIT) exam with the BC Environmental Operators Certification Program (EOCP), or currently enrolled in a post-secondary Wastewater Treatment Technology Program. The incumbent must possess a valid Class 5 BC Driver's License, and a Level 1 First Aid Course would be an asset. Knowledge of safe work procedures, WHMIS, basic laboratory practices, and Transportation of Dangerous Goods are also assets.

POSITION DETAILS

These are temporary full-time (40 hours per week) Union positions, starting April 28, 2025, up to December 31, 2025, with the possibility of ending early depending on the operational needs of the department. Applicants must be able to work weekend shifts. The (2024) rate of pay is \$29.60 to \$31.16 per hour, plus 12.4% in lieu of benefits including vacation and statutory holidays.

Job Summary

Under the supervision of the Chief Operator, the Operator Trainee performs a variety of unskilled and semi-skilled tasks in Wastewater operations. This role supports the Chief Operator in day-to-day activities in operations, maintenance, and routine housekeeping of the facilities. This position supports the department by assisting team members in their duties, as required, to meet service expectations, departmental goals, and objectives.

Primary Duties and Responsibilities

- Assists in the inspection of systems to ensure proper operation and corrects and/or reports abnormal conditions.
 - Enters data into operational /maintenance records and logbooks as appropriate.
 - Assists in pump station operation and routine maintenance tasks.
 - Performs plant process operational adjustments as directed.
 - Assists in the routine maintenance and operations of the sludge dewatering equipment and polymer systems.
 - Performs routine emergency systems tests.
 - Assists in the monitoring and routine maintenance of force mains, trunk sewers and pump stations including related appurtenances.
 - Assists in the repairs of pumps and other plant and pump station equipment.
 - Assists in Plant and Pump Station chemical handling, receiving and transfers.
 - Reviews, adheres to, and supports the adherence to safe work procedures in the workplace and generally promotes a safe work environment.
 - Performs other related duties, as required.
