REGIONAL DISTRICT OF NANAIMO BYLAW NO. 1807

A BYLAW TO SET FEES RELATED TO WASTE STREAM MANAGEMENT LICENSING BYLAW NO. 1803, 2022

WHEREAS under section 25(3)(g) of the *Environmental Management Act* (British Columbia) a regional district may make bylaws respecting fees in respect of the regulation of management of municipal solid waste and recyclable materials, including waste stream management licenses;

AND WHEREAS the Regional District of Nanaimo has, under Waste Stream Management Licensing Bylaw No. 1803, 2021 established a system of waste stream management licenses and those bylaws contemplate the imposition of fees with respect to such licensing systems;

NOW THEREFORE the Board of the Regional District of Nanaimo in open meeting assembled enacts as follows:

1. TITLE

1.1 This Bylaw may be cited as "Waste Management License Fees Bylaw No. 1807, 2022".

2. DEFINITIONS [BL1807.01]

2.1

"Disposal Levy"	means the fee payable by a Licensee in respect of Mixed Municipal Solid Waste deposited at: A Material Recovery Facility located out of region; and, A Disposal Facility located in or out of region.
	The fee shall be based on the tonnage of material deposited multiplied by the applicable rate based on class of facility set by this bylaw.
"License Fee"	means the fee payable for a License, in the applicable amount established by District bylaw from time to time, and which may differ for Base Licenses, Tier 1, Tier 2, Tier 3, Tier 4 and Tier 5 Licenses.

3. FEES [BL1807.01]

- 3.1 The Regional District of Nanaimo hereby imposes the application and administration fees set out in Schedule 1 payable under and in accordance with Waste Stream Management Licensing Bylaw No. 1803, 2021.
- The Regional District of Nanaimo hereby imposes the **Licensee Fees** set out in Schedule 2 payable under and in accordance with Waste Hauler Licensing Bylaw No. 1813, 2022.

- The Regional District of Nanaimo hereby imposes a **Disposal Levy** payable under and in accordance with section 12.1 of Waste Hauler Licensing Bylaw No. 1813, 2022 at the per tonne **disposal levy** amount set out in Schedule 2. [BL1807.01]

4. SEVERABILITY [BL1807.01]

4.1 If any portion of this bylaw is deemed ultra vires, illegal, invalid, or unenforceable in whole or in part by any court of competent jurisdiction, that portion shall be severed from this bylaw and shall not affect the validity or enforceability of the remainder of the bylaw.
