

Well Water Testing Rebate Pre-approval Application



The RDN offers 50% rebates (to a maximum of \$300 rebated) for private domestic Well water testing to better understand the health of regional groundwater. When the rebate is open, applications are processed on a first come, first served basis. If you are approved, the RDN will issue you an ID to submit with your well water sample to the lab. Six weeks processing. Program details at rdnrebates.ca.
