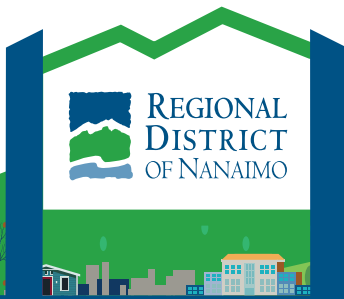

## Organics GREEN LID

AND GRAINS

TEA BAGS, COFFEE  
GROUNDS AND FILTERS



FOOD-SOILED PAPER  
TOWELS AND CONTAINERS  
MADE OF CARDBOARD/  
BOXBOARD



LEAVES, GRASS AND  
LIGHT YARD TRIMMINGS

INCLUDES  
TWIGGS, SMALL  
BRANCHES AND  
PRUNINGS



Maximum length 60 cm (2 ft)



Maximum diameter 1.5 cm (0.5 in)

! If you use a liner bag (optional), make sure it is stamped with one of these logos to guarantee it is **certified compostable**.



**THE FOLLOWING ITEMS  
ARE PROHIBITED:**

- Plastics, including liner bags that are not certified compostable
- Soil, sod or rocks
- Diapers and other personal hygiene items
- Pet waste, including cat litter
